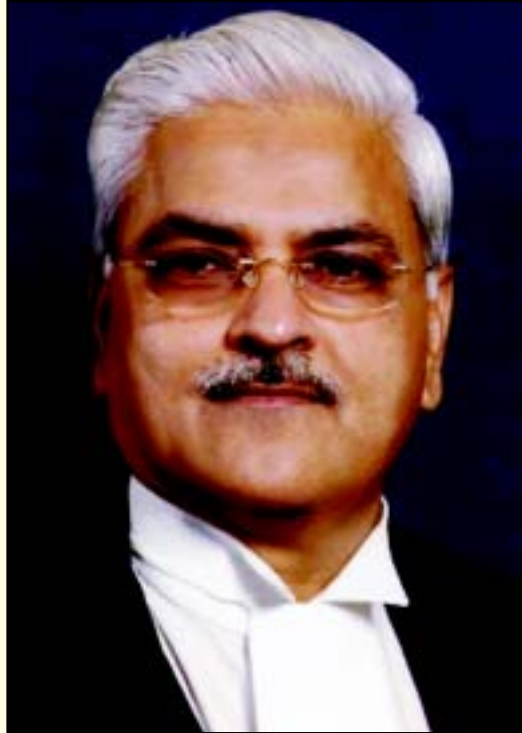

## REPORT 2008

The Quest for justice has been an arduous journey for humanity. Developments in Law and justice institutions have been the hallmark of democracies world over. Our motto not only reflects the ancient wisdom of our forefathers, but it is also a beacon to cherish and practice for future generations.

Our constitution mandates justice for all. Justice not only in form, but in substance and timely. A.P.Judicial Academy, a pioneer in India in the field of judicial and legal education since 1991, takes inspiration from the constitutional objectives and aims to provide continuing legal education on matters of contemporary relevance through eminent judges, jurists and specialists in their field to address and interact with the participants, who include judicial officers in the state, ministerial officers of the district judiciary and High Court, police officers, public prosecutors, administrators, on legal, judicial and general matters of contemporary public importance.

The Andhra Pradesh Judicial Academy, a reputed Category-I Institution of our State has been functioning as a comprehensive training Institute for the State Judiciary. The Academy has been conducting various training programmes for all cadres of Judicial Officers in the State on legal, constitutional, and other related faculties, techniques and tools to render timely and effective justice and latest developments in the law, new statutes touching judiciary in particular and society in general like Information Technology Act, Environmental Laws, Right to Information Act, Intellectual Property Laws etc., apart from other programmes.

The Hon'ble the Chief Justice of Andhra Pradesh as Patron-in-Chief and four Senior Judges of our High Court as President and Board of Governors, guide the functioning of the Academy.

The Academy is headed by a Director, and assisted by an Additional Director, two Senior Faculty Members, all of the rank of District Judge, a Deputy Director of the cadre of Senior Civil Judge, an Assistant Director and an Administrative Officer of the cadre of Junior Civil Judge.

The Director, Additional Director, two Senior Faculty Members, a Deputy Director, and an Assistant Director are the in-house Faculty. The Guest Faculty consists of the present and former Judges of the Supreme Court and the High Court; serving and retired Senior District and Sessions Judges; Advocates; Administrators; Professors; Police Officers; Faculty of other educational training institutions and other persons of eminence.

## LAYING FOUNDATION STONE FOR NEW BUILDING COMPLEX OF THE ACADEMY



In view of increase in work load and new recruitment, extended activities, the need for a modern, sufficiently big and befitting building for our academy, at the request of our high court, the government had allotted and handed over acrs.20.00 of land in survey no.1266 at Shameerpet village, Rangareddy district for construction of the new building complex for our academy on 6.11.2003.

The foundation stone for the new building complex was laid on 7.2.2004 by Hon'ble Sri Justice V.N.Khare, Chief Justice of India, presided over by Hon'ble Sri Justice Devinder Gupta, Chief Justice of A.P. and Patron-in-Chief of our Academy, in the august presence of Hon'ble Sri N.Chandrababu Naidu, Chief Minister of A.P. The special guest of the occasion was Hon'ble Sri Justice P.Venkatarama Reddi, Judge, Supreme Court of India. The guest of honour was Hon'ble Dr.Justice A.R.Lakshmanan, Judge, Supreme Court of India. Hon'ble Sri Justice B.Sudershan Reddy, President of the Academy, Hon'ble Sri Justice G.Bikshapathy, Hon'ble Sri Justice J.Chelameswar, Members, Board of Governors of the Academy were present on the occasion.

## **AN OVERVIEW OF THE PROGRAMMES CONDUCTED BY THE A.P.JUDICIAL ACADEMY.**

### **I) XIV Basic Course Part-I, Phase-I and II (Induction course) for Junior Civil Judges selected in the year 2005 from 19.9.2005 to end of January, 2008**

As mandated by the Hon'ble Supreme Court in All India Judges Association and others Vs. Union of India and others (2002 (4) SCC 247), to impart training of not less than one year, preferably two years for fresh recruits in the cadre of Junior Civil Judges, the Academy has commenced XIV Basic Course (one year) for 89 newly recruited Junior Civil Judges by dividing them into three batches. The training for the first batch commenced on 19.9.2005. All the 89 newly recruited Junior Civil Judges have completed the institutional training phase-I and II by the end of January 2007. Later the 89 Junior Civil Judges were divided into two batches and the first batch completed the XIV Basic Course Part-II (Practical Training for 4 months) by the end of May 2007.

### **XIV Basic Course Part-II (Practical Training for 4 months) for Second batch. from 4-6-2007 to 3-10-2007**

The trainee Junior Civil Judges were exposed to different Survey Systems, maintenance of land records, and were taken to field visit for actual survey and measurements. The trainee Junior Civil Judges were trained by the Officials of the Forensic Science Laboratory, Government of Andhra Pradesh. Eminent Professors of Osmania Medical College also trained them in Forensic Medicine. As part of training, the trainees visited the Central Prison, Cherlapally, and Prison for women, Juvenile Homes, Cyber Crime Police Station and also the Police Academy. In order to get exposure on the importance of environment, the trainees visited the Pollution Control Board, Common Hazardous Waste Treatment storage and disposal plant, Common Effluent Treatment Plant at Jeedimetla, apart from being trained in the entire environment related laws at the Academy.

### **II) Two day Training programme for recently promoted District Judges from 21-7-2007 to 22-7-2007**

In this course, the trainees were exposed with interaction to the subjects Criminal appeals, Revisions by the then Director Sri N.Ravishanker; Motor Accident claims by Hon'ble Sri Justice B.Seshasayana Reddy; Appreciation of



evidence by Hon'ble Sri T.Ch.Surya Rao; Sessions trials and Judgment by Hon'ble Dr.Justice G.Yethirajulu. These subjects covered latest trends on the subjects and case law.

### **III) 36<sup>th</sup> Course on Administration for Ministerial Officers of Senior Civil Judge Courts from 24.7.2007 to 1.8.2007**

On 24.7.2007 the 36<sup>th</sup> One Week Course on Administration for Ministerial Officers of Subordinate Courts was commenced. It was organized to train the Chief Ministerial Officers of the Subordinate Courts on Administration. The subjects included A.P.C.C.A. Rules, A.P. Fundamental Rules, A.P. Treasury Code, A.P. Financial Code, A.P. Accounts Code, A.P. Budget Manual, A.P. Leave and Pension Rules apart from the checking of Civil and Criminal Proceedings, Stamp Act, and Registration Act.

### **IV) XIV Basic Course Part-III (Final and Reflective and Integrated Learning at the Academy for two months) for Junior Civil Judges selected in the year 2005 (1<sup>st</sup> Batch) from 8.10.2007 to 7.12.2007**



The final phase of first batch of 41 Junior Civil Judges of XIV Basic Course Part-III (Final, Reflective and Integrated Learning at the Academy for two months) commenced on 08.10.2007. In this programme, the trainees were exposed to



the substantive and procedural laws, apart from subject of Judgment writing and Interlocutory Orders. To improve English Language skills of the trainees, lectures by the eminent Professors of the Department of English, Osmania University, Hyderabad were arranged. The trainees were also given legal problems and exercises as part of integrated learning. They were also trained in the operation of computers and laptops. Hon'ble Sri Justice B.Seshasayana Reddy, Judge, High Court of A.P. and Hon'ble former Judges of the High Court Sri Justice Vaman Rao, Sri Justice V.Neeladri Rao and Sri Justice G.Bikshapathy have addressed and interacted with the officers on various subjects. On successful completion of XIV Basic Course for the first batch of 41 Junior Civil Judges on 7<sup>th</sup> December, 2007 Hon'ble the then Acting Chief Justice of Andhra Pradesh Sri Justice Bilal Nazki, Patron-in-Chief of the Academy and Hon'ble Sri Justice B.Prakash Rao, President of the Academy participated in the valedictory session, distributed certificates and addressed the officers.

#### **V) IV Foundation Course for five newly appointed District Judges (entry level) from 3.12.2007 to 02.02.2008**

On 3<sup>rd</sup> December, 2007 Hon'ble Sri Justice A.Gopal Reddy, Member, Board of Governors of the Academy inaugurated IV Foundation Course for five newly appointed District Judges (entry level) by direct recruitment. As per the orders of the Hon'ble High Court, the five District Judges were trained for two months. In the said training, the trainee District Judges were exposed to various substantive and procedural laws apart from laws on Administration. They were also trained on computers. Hon'ble Sri Justice V.Eswaraiah, Hon'ble Sri Justice G.Raghuram, Hon'ble Sri Justice T.Ch.Surya Rao, Hon'ble Dr.Justice G.Yethirajulu, Hon'ble Sri Justice K.C.Bhanu and Hon'ble Sri Justice B.Seshasayana Reddy addressed and interacted with the trainee District Judges on various subjects.

#### **VI) XIV Basic Course Part-III (Final Reflective and Integrated Learning at the Academy for two months) for Junior Civil Judges selected in the year 2005 (2<sup>ND</sup> Batch) from 10.12.2007 to 08.02.2008**

The final phase of second batch of 46 Junior Civil Judges of XIV Basic Course Part-III (Final Reflective and Integrated Learning at the Academy for two months) commenced on 10.12.2007. In the said training programme, the trainees were exposed to the substantive and procedural laws, apart from Judgment writing and Interlocutory Orders. To improve English Language skills of the trainees, lectures by eminent Professors of the Department of English, Osmania University, Hyderabad were arranged. The trainees were also given legal problems and exercises as part of integrated learning. They were trained in the operation of computers and laptops. Hon'ble Sri Justice G.Raghuram, Hon'ble Sri



Justice T.Ch.Surya Rao, Hon'ble Sri Justice B.Seshasayana Reddy, Hon'ble Sri Justice K.C.Bhanu, and Hon'ble Sri Justice G.V.Seethapathi, Judges of High Court of A.P. have addressed and interacted with the officers on various subjects.

On successful completion of the XIV Basic Course for the second batch of 46 Junior Civil Judges on 8<sup>th</sup> February, 2008 Hon'ble the Chief Justice of Andhra Pradesh Sri Justice Anil.R.Dave, Patron-in-Chief of the Academy and Hon'ble President Sri Justice B.Prakash Rao, Hon'ble Sri Justice A.Gopal Reddy, Hon'ble Sri Justice G.Raghuram, Members, Board of Governors of the Academy have participated in the valedictory session, distributed certificates and addressed the officers.

### **VII) 19<sup>th</sup> Orientation Course for newly promoted Senior Civil Judges held from 18.2.2008 to 01.03.2008**

The 19<sup>th</sup> Orientation Course was conducted for the newly promoted 30 Senior Civil Judges. In the said course the participant officers were exposed to various subjects viz., family laws, land acquisition, sessions trials, interpretation of statutes, succession laws, law of insolvency etc. that would be useful to them in dispensing justice as Senior Civil Judges. The In-house faculty dealt with all the subjects in this course. Apart from the subjects mentioned, the participant officers were also trained in English language speaking and writing skills with practical exercises by the active interaction of the Professors of the Department of English, Osmania University. Prof.M.Sreedharacharyulu, NALSAR University of Law, Sri G.Krishna, Asst. Professor of Pendekanti Law College interacted with the officers on the subjects Dynamics of Right to information and Interpretation of Statutes respectively. Sri S.Khaleel Ahmed, Principal, Sri Prasanna Law College of Kurnool addressed and interacted with the Officers on Succession, Comparative Study of Hindu, Mohammadan and Christian

Laws. Professor M.Narayana Reddy of Forensic Medicine explained the importance of Forensic Medicine relating to sexual and other serious offences. Hon'ble Sri Justice G.Raghuram, Hon'ble Sri Justice T.Ch.Surya Rao, Hon'ble Sri Justice B.Seshasayana Reddy, Hon'ble Sri Justice G.V. Seethapathy have addressed and interacted with the officers on Law of Precedents; Appreciation of Evidence & Judgment Writing, Law of Insolvency and Judicial Personality respectively.

### **VIII) 10<sup>th</sup> Specialized Course for Senior Civil Judges held from 26.03.2008 to 02.04.2008**

This Course was held for 28 Senior Civil Judges from 26.3.2008 to 02.04.2008. Hon'ble Sri Justice C.V.Ramulu, Judge, High Court of A.P. has inaugurated the course. In this course the participant officers were exposed to various subjects viz., Land acquisition, Civil Appeals, Sessions Trials, Specific Performance, Law on Execution, Sentencing, Rent Control Appeals etc. which would be useful to them in dispensing justice as Senior Civil Judges. The In-house faculty dealt with all the said subjects. Apart from the subjects mentioned, Prof.M.Sreedharacharyulu of NALSAR University of Law has interacted with the officers on Dynamics of Right to information. Sri S.Khaleel Ahmed, Principal, Sri Prasanna Law College of Kurnool has interacted with the Officers on Succession, Comparative Study of Hindu, Mohammadan and Christian Laws. Prof.Y.F.Jaya Kumar, Chairman, Board of Studies, O.U., Hyderabad has interacted with the trainees on the Emergence of Alternate Dispute Resolution. Sri Venu Bhagavan, Director, V Build, Hyderabad interacted with the trainees on the Art of Balancing. Hon'ble Sri Justice T.Ch.Surya Rao, and Hon'ble Sri Justice C.V.Ramulu, have addressed and interacted with the officers on Sessions Trial and Appreciation of Evidence, and Judicial Ethics respectively.

### **IX) 11<sup>th</sup> Specialized Course for Senior Civil Judges held from 15.04.2008 to 22.04.2008**

This Course was held for 30 Senior Civil Judges from 15.04.2008 to 22.04.2008. Hon'ble Sri Justice Ramesh Ranganathan, Judge, High Court of A.P. has inaugurated the course. In the said course, the participant officers were exposed to various subjects viz., Land acquisition, Civil Appeal, Sessions Trials, Specific Performance, Law on Execution, Sentencing, Rent Control Appeals, and Law of Insolvency etc. which would be useful to them in dispensing justice as Senior Civil Judges. The In-house faculty dealt with all the subjects. Apart from the subjects mentioned, Prof.M.Sreedharacharyulu of NALSAR University of Law interacted with the officers on Dynamics of Right to information. Sri S.Khaleel Ahmed, Principal, Sri Prasanna Law College of Kurnool has interacted with the Officers on Succession and Comparative Study of Hindu, Mohammadan and Christian Laws. Professor Y.F.Jaya Kumar, Chairman, Board of Studies, O.U., Hyderabad has interacted with the trainees on Family Laws. Sri N.Naveen, a Chartered Accountant and a specialist

on the subject of Art of Living has interacted with the trainees on seven habits of highly effective people. Dr. Vepa P.Saradhi, Senior Advocate of Supreme Court, an eminent author and former A.G. (Sikkim) has addressed the officers on interpretation of statutes.

### **X) III Orientation Course for newly recruited Junior Civil Judges held from 01.05.2008 to 07.05.2008**

The III Orientation Course was held for 64 newly recruited Junior Civil Judges from 01.05.2008 to 07.05.2008. Hon'ble Sri Justice Anil R.Dave, Chief Justice of A.P. & Patron-in-Chief of the Academy, Hon'ble Sri Justice B.Prakash Rao, Judge, High Court of A.P. & President of the Academy, Hon'ble Sri Justice A.Gopal Reddy, Hon'ble Sri Justice G.Raghuram, Hon'ble Sri Justice G.Bhavani Prasad, Members, Board of Governors of the Academy have participated in the inaugural session and addressed the trainees. In this course, the trainee Junior Civil Judges were exposed to procedural laws viz., Code of Civil Procedure, Code of Criminal Procedure, Evidence Act etc., to equip them to deal with their day to day duties as judicial officers on urgent basis, before their regular training starts at the academy. The In-house faculty has interacted with the trainees on all subjects and shared their experiences with the trainees to familiarize them with the procedures to be followed in disposing of urgent applications, passing remand orders, writing Docket Orders, granting of Interim Injunctions, writing judgments, civil and criminal and how to face the immediate challenges on assuming the office. Hon'ble Sri Justice C.V.Nagarjuna Reddy addressed the trainees on Judicial Ethics.

### **XI) III Course on Inspection of District Courts and Addl.District Courts for the staff members of the High Court from 30-5-2008 to 6-6-2008.**

The Registry of the Hon'ble High Court faced shortage of experienced staff members for inspection work who have knowledge on judicial side and Rules and Regulations, Civil and Criminal Rules of Practice, besides the Circular instructions issued by the High Court from time to time. To overcome the shortage of experienced staff members, the Hon'ble High Court felt the immediate need and necessity to impart training to the staff members. Thus this programme came to be conducted. In this Course 45 staff members were nominated by the High Court.

The programme was inaugurated by Hon'ble Dr.Justice G.Yethirajulu, who as a guest speaker enlightened and interacted with the participants on "Maintenance of Civil Registers, Checking of civil proceedings, Maintenance, preservation and destruction of records, Record Room, Inspection of civil and criminal work of District Courts over a period of six sessions.





Hon'ble Sri Justice G.V.Seethapathi addressed and interacted with the trainees on checking and maintenance of various criminal Registers.

Hon'ble Former Judge Sri Justice Ch.S.R.K.Prasad taught and interacted with the trainees on A.P.C.F.& S.V.Act and Rules, maintenance and checking of relevant registers and Central Nazareth.

The Vice Chairman of A.P.Administrative Tribunal Sri Y.V.Ramakrishna addressed and interacted with the trainees on inspection of administrative and general work of District Courts. Sri A.Venkaiah, a noted expert taught and interacted with the trainees on Financial Rules and Procedures, Maintenance of Service Registers, Rules etc. Sri D.V.Ramana Murthy, District Judge (Retd.) enlightened and interacted with the trainees on Stores, stationary, verification of Registers in Accounts Section. Sri N.Vidya Prasad, District Judge (Retd.) interacted with the trainees on Copyist establishment, A.P.Civil Rules of Practice and Circular Orders.

Sri Venu Bhagavan, Director "V" Build spoke about passion for excellence. Smt.Mastanamma, Director, A.P.Judicial Academy enlightened and interacted with the trainees on Registration, Stamp duty and penalties. Sri S.Surendrababu Reddy, Additional Director, A.P.Judicial Academy enlightened and interacted on Properties and Fines, procedures and Registers. Sri R.Damodar, Sri P.Mohan Rao, Sr.Faculty Members, A.P.Judicial Academy and Sri A.Santosh Reddy, Dy.Director, A.P.Judicial Academy interacted with the trainees on A.P.Civil Courts Act, Limitation Act, A.P.Civil Rules of Practice and Circular Orders respectively.

## WORKSHOPS / COLLOQUIA / JUDICIAL EXCHANGE

**I) A Two day Colloquium on “ Justice Delivery in Human Trafficking Crimes”** for Judicial Officers, Prosecutors and Police Officers on 4<sup>th</sup> and 5<sup>th</sup> August, 2007 in collaboration with UNODC and C.I.D., A.P.

Hon'ble Sri Justice G.S.Singhvi, Chief Justice, High Court of A.P & Patron-in-Chief has addressed the gathering and set the agenda for the colloquium. Sri M.Ratan, Addl. Director General of Police, C.I.D., Nodal Officer, Anti Trafficking, A.P pointed out the efforts of the State of Andhra Pradesh in curbing human trafficking. Sri Gary Lewis, Representative, UNODC, New Delhi presented the International perspective and the efforts of the United Nations in curbing human trafficking. Dr.P.M.Nair, Project Co.ordinator, UNODC who is behind the planning for colloquium addressed the gathering and interacted with the participants. Hon'ble Sri Justice G.V.Seethapathi has participated in the interactive session. Smt.T.Rajani, District and Sessions Judge / Mahila Court, Hyderabad has interacted with the participants. Ms.Aparna Bhatt, Advocate of Supreme Court of India enlightened the audience on “Laws and recent Court Rulings on Anti-Human Trafficking”. Sri Shivdhar Reddy, D.C.P.South Zone, Hyderabad City presented the experience at Guntur and the initiative taken by the police in curbing human trafficking. Sri Mahesh Bhagwat, Superintendent of Police (Women Protection Cell) C.I.D. presented power point presentation and interacted with the participants on the effort of the police in curbing human trafficking with practical problems. There was a visit arranged to PRAJWALA, a N.G.O. in Old City for the participants to experience the efforts of N.G.O. and the problems faced by them on the subject.

Hyderabad, Dr.C.N.Gopinatha Reddy, Director, A.P.Police Academy have interacted with the participants and explained the challenges in the present law enforcement process. Sri N.Ravi Shankar, the then Director, A.P.Judicial Academy and Sri M.Bhaskar, the then Director of Prosecutions have interacted with the participants on the role of prosecution in justice delivery in trafficking crimes and victim / witness support. Dr.Buchi Reddy, Professor of Forensic Medicine, APPA interacted with the participants on role of Forensics in age determination / D.N.A. Finger Printing. Later in the concluding session Dr.P.M.Nair, Sri T.Krishna Prasad, Superintendent of Police moderated with the participants on plan of action in expediting justice delivery in human trafficking crimes.

**II) Judicial Exchange on ‘Human Rights in the Administration of justice’** was conducted in collaboration with Commonwealth Human Rights Initiative (CHRI) on 27<sup>th</sup> & 28<sup>th</sup> October 2007. The moderator for this programme was Ms.Maja Daruwala, Director, Commonwealth Human Rights (CHRI). Hon'ble Sri Justice B.Prakash Rao, President, A.P.Judicial Academy has addressed the gathering and set the tone for the programme. Hon'ble Sri Justice K.Rama Swamy, former Judge, Supreme Court of India delivered the inaugural address referring to various landmark judgments of the Hon'ble Supreme Court and the need for awareness on finer points of Human Rights in the administration of justice.





Hon'ble Sri Justice G.S.Singhvi, Chief Justice of A.P. and Patron-in-Chief of the Academy has actively participated in the proceedings and encouraged the participants to involve themselves in the cause of Human Rights.

Hon'ble Sri Justice K.Rama Swamy, former Judge, Supreme Court of India has actively participated in the deliberations. Sri Bojja Tarakam, Senior Advocate, High Court of A.P., Sri Ajit Barihoke, Registrar

General, Delhi High Court, Sri L.R.Singh, Advocate, Supreme Court of India headed the panel discussion. Hon'ble Sri Justice G.S.Singhvi, Chief Justice of A.P. and Patron-in-Chief of the Academy, Hon'ble Sri Justice G.Raghuram, Hon'ble Sri Justice G.V.Seethapathi, Judges, High Court of Andhra Pradesh have participated in the discussion on expectations of the superior judiciary from the subordinate judiciary.

### **REGIONAL REFRESHER COURSES**

In view of shortage of accommodation at our Academy and large number of officers who could not be exposed to refresher courses at the Academy on latest trends in the field of law, techniques of timely justice, the Hon'ble Board of Governors of the A.P. Judicial Academy have resolved in the meeting dated: 5.11.2007 to conduct Regional Refresher Courses for all categories of Judicial Officers in the State. Accordingly, on 15.12.2007 Regional Refresher Courses were held in the four regions of the State on the same day and in the fifth Region at Hyderabad on 22.12.2007.

#### **Region-1 : Visakhapatnam**

The Regional Refresher Course for all categories of Judicial Officers of the Districts of Visakhapatnam, East Godavari, Vizianagaram and Srikakulam was held at Visakhapatnam on 15.12.2007 in the Ambedkar Assembly Hall, Andhra University, Visakhapatnam.

The programme commenced with welcome address by the Director of the Academy and inaugural address by Hon'ble Sri Justice B. Prakash Rao, President, A.P. Judicial Academy. Hon'ble Sri Justice C.V.Nagarjuna Reddy addressed

the officers on 'Judging and Judgment writing'. Hon'ble Sri Justice Sri R.Kantha Rao, (the then District Judge, Visakhapatnam) has addressed the participant officers on appreciation of evidence and judgment writing.
